# How to Get Repairs

If you have serious defects in your unit which affect you and your family's health or safety, you should:

<u>Mocument the Problem</u>- When you move-in and later as problems arise, go room by room, list all defects and take photographs of them.

Request Repairs- Write your landlord or manager a letter identifying each defect and requesting repairs. Keep copies of all correspondence.

✓ <u>Do Your Part</u>- Cooperate fully with all reasonable repair efforts. You are entitled to at least 24 hours written notice before entry to get bids or make repairs. Civil Code § 1954. Keep a journal or calendar and note what is done, by whom and when. If the repairs do not solve the problem, write to your landlord or manager.

**△**Report the Problem- If the defects are not repaired within 30 days (or less in an emergency) contact local code enforcement: https://www.sandiegocounty.gov/content/sdc/deh/fhd/housing/housingcomplaints.h tml During the site visit, point out all defects to the inspector and request a copy of each letter or notice sent to the landlord, for your records.

**Follow Up**- Follow up with code enforcement until all defects are repaired. If this does not resolve the problem, contact us.

#### Who We Are

### What the Law Requires

Every rental unit must have:

- △ Effective weather protection, with a sound roof and exterior walls, including unbroken windows and doors
- △ Adequate security, with windows and doors that lock, including deadbolts on each exterior door
- △ Plumbing, gas, heat, electrical lighting and wiring in good working order
- △ A smoke alarm (with a 10-year, non-removable battery per Health & Safety Code § 13114) on each floor, in each bedroom and hallway and, if there are gas appliances, a carbon monoxide detector
- △ Clean common areas, with adequate trash receptacles
- △ Floors, stairways and railings in good repair
